Information report

Under the Special Education Needs and Disability Regulations 2014, schools are required to publish, and keep under review, information about the services that they expect to be available for children and young people with disabilities and Special Education Needs (SEND) aged 0-25 years.

The 0-25 SEND Code of Practice (2015) identifies 'four broad areas of special educational need and support. Learning needs within these four areas are provided for at Rivers Primary Academy.

Four Broad Areas of SEND

Cognition and Learning

Where a child or young person learns at a slower pace than their peers, even with appropriate differentiation. This may be a specific learning difficulty (SpLD). SpLD affects one or more specific aspects of learning. This encompasses a range of conditions such as dyslexia, dyscalculia and dyspraxia.

Social, emotional and mental health difficulties

Children and young people may experience a wide range of social and emotional difficulties which manifest themselves in many ways. These may include becoming withdrawn or isolated, as well as displaying challenging, disruptive or disturbing behaviour. These behaviours may reflect underlying mental health difficulties such as anxiety or depression, self-harming, substance misuse, eating disorders or physical symptoms that are medically unexplained. Other children and young people may have disorders such as attention deficit disorder, attention deficit hyperactivity disorder or attachment disorder.

Sensory and/or physical

Some children and young people require special educational provision because they have a disability which prevents or hinders them from making use of the educational facilities generally provided. These difficulties can be age related and may fluctuate over time. Many children and young people with vision impairment (VI), hearing impairment (HI) or a multi-sensory impairment (MSI) will require specialist support and/or equipment to access their learning, or habilitation support. Children and young people with an MSI have a combination of vision and hearing difficulties. Information on how to provide services for deafblind children and young people is available through the Social Care for Deafblind Children and Adults guidance published by the Department of Health.

Communication and interaction

Children and young people with speech, language and communication needs (SLCN) have difficulty in communicating with others. This may be because they have difficulty saying what they want to, understanding what is being said to them or they do not understand or use social rules of communication. The profile for every child with SLCN is different and their needs may change over time. They may have difficulty with one, some or all of the different aspects of speech, language or social communication at different times of their lives.

Processes and procedures for supporting children with SEND

How does the school know if my child needs extra help and what support is given?

We have a number of methods to help us identify if a child needs extra help. If a parent, carer or teacher raises concerns a child will be monitored. Steps included are shown below. If the child already has been identified with a special need before they start our school; we liaise with adults and services who already know them. Further details can be found within our SEND policy.

How will the curriculum be matched to my child's needs?

High quality teaching and our carefully mapped out curriculum will ensure your child's needs are met within lessons. In the classroom, we cater for all children using a variety of teaching styles and a range of visual, auditory and hands on equipment to aid learning.

The progress of all children is monitored and rigorously and reviewed regularly. Teachers take account of the needs of the individual child and plan different tasks and materials appropriately. Pupil cohort and progress meetings are held three times a year with the Head Teacher, SENCo and class teacher to discuss suitable programmes for each child and support staff with meeting each individual child's needs. This may sometimes involve putting in place training for staff or support within classes for children. Targets are also set to support children's individual needs and are regularly updated.

For some children specialist equipment may be used e.g. coloured overlays, concentration cushions, twizzlers, pen and pencil grips, special scissors, timers. Across school we have a wide variety of resources, iPads, talking buttons, laptop computers, lego and others.

Other adaptations may be to the environment depending on the child's needs. Occupational therapy or other specialists advise us where adaptations are required.

Our curriculum is carefully created to be 'ambitious for all' and lesson resources and focuses are targeted to meet children's individual needs. Our smart starts also aim to focus on specific targets.

The SENCO is responsible for evaluating the provision in place and monitoring effective use of the provision. Changes are made where required to ensure the child's needs are sufficiently met.

Staff regularly attend CPL sessions with updates on SEND practice as well as ensuring high quality teaching is delivered. Other specialist training includes ASD training for all staff. Key members of staff also have training to deliver precision teaching, talk boost and other specialist interventions. Medical training is also in place where required which includes where children may require a catheter or gastrostomy.

What support will there be for my child's overall well-being?

We have a very supportive pastoral team at Rivers Primary Academy who work alongside both families and children to support their social, emotional and mental health needs. They also work alongside families offering early help and support in other areas of their lives in order to ensure every child's needs are met. Our positive approach to behaviour management and procedures in place ensure bullying and other behaviour problems are prevented and handled appropriately.

The support we can provide in school may include:

- Pastoral support groups
- Pupil voice
- Behaviour programmes including rewards and sanctions.
- Lunchtime and after school clubs
- Risk assessments are put in place for out of school activities and for individual children at risk.
- If 1 to 1 support is deemed necessary for a school trip we will work with you to develop an appropriate care plan and explain the provision we have put in place.
- Phase assembly targeting key areas

We strive to create an inclusive environment where all children are made to feel equal. Mixed ability groupings and ensuring children are educated on treating children equally ensures a welcoming environment.

How does the school cater for medical needs?

Medicines can be administered in school with signed parental permission. There are nominated first aiders in school. If your child has significant medical needs you will need to speak to the SENCO to discuss how we can best support you and your child. This might include drawing up a Health Care Plan.

The school site is wheelchair accessible; We have disabled toilets that are large enough to accommodate changing and suitable for wheelchair users. We have an accessibility plan, which is available to view. We have a hygiene room with a changing bed but no toilet within this room. Our 'Administering medicine' and 'Disability, Equality and Accessibility' policies contain further detail on the support provided and systems in place.

How will Rivers prepare and support my child for joining their school or transferring to another school?

- A series of parent and child taster sessions are arranged in preparation for their September start.
- Transition into Reception will involve contact with previous settings and agencies already involved. All existing target setting and identification of need processes are shared between schools so support can continue. Parent meetings with the EYFS lead and SENCO are arranged where required.
- When children with SEND move into successive year groups it is supported by meeting the teacher time and taster sessions in the new class and often social stories that are taken home to reduce anxieties.
- Parents and children who are joining our school mid-term are encouraged to visit the school before they start.
- As your child makes the transition to Secondary school again we will contact and
 discuss your child's needs with their Secondary school colleagues, invite them to
 observe your child in our setting and through dialogue with you and your child set up
 appropriate transition visits to support a smooth transition to Secondary school.
